John reported that fotpin has made good progress on several fronts in the last three months. PCS are very appreciative of our efforts and achievements, and in particular weeding.

Two planting projects are coming up in Autumn and should be announced shortly.

John had a very productive meeting with PCS rangers and further regular meetings are planned, to be held shortly after our committee meetings.

## 8) International Student Volunteers (ISV)

The committee was disappointed that ISV was not able to go ahead with this project with fotpin in 2013 in view of the global (and particularly USA) financial situation. The research and planning done by Matt and Elizabeth will be useful for future such projects, when they are possible.

## 9) Weed Management ([Attachment D](#))

Warren presented a report summarising the nature of the weeding season in the last 3 months. He highlighted the major weeds posing a threat this season, and how the weeding effort has been expended.

## 10) Native Grass Regeneration Project

- i) Treatments planned for implementation in April include slashing the crop plots and sugar addition.
- ii) Fire treatments currently being organised in consultation with Parks staff.
- iii) Data analysis from 2012 under way.

The project continues to progress well, strongly supported by particular fotpin volunteers.

## 11) Biodiversity Monitoring Project

The written report on the fotpin bio-monitoring project is in train and expected shortly. fotpin has been quite successful in terms of results and methodology according to informal discussions. Elizabeth and John will need to check progress on the plantings on a plant by plant basis and undertake a follow-up report in Spring.

## 12) Revegetation Strategy

*Upcoming plantings*

There has been discussion about species and timing. Three or four hundred plants are planned for in April/May/June in North Kama as part of the Woodland Restoration Project, with fotpin support to be invited via our usual channels from fotpin volunteers.

**Action: John.** Follow up coordination of planting day/s with Greening Australia and engagement of fotpin volunteers.

## 13) Soil and Water Erosion (includes Assessment Program and works)

Pax reported that Greening Australia has committed to fund, under their *ACT LandKeepers – Veglink* program, the purchase of an additional 20 coir logs to finish the instalment of these erosion control devices at erosion control Site 2 in the Bottom Pinnacle.

The coir logs have been delivered, and will be installed at the first opportunity

## 14) Rabbit control

Further rabbit control is planned for the reserve in early April, in the meantime fotpins will map rabbit warrens as they go about weed control activities. Warren will provide this information to Parks for use by their contractors.

## 15) Kangaroos

A survey of Pinnacle kangaroos is yet to be confirmed by PCS, however fotpin is supporting a kangaroo survey in Kama Nature Reserve on 10 March 2013.

## 16) Focal Point

Little has changed since the previous meeting

There was some confusion about timing of the testing but it now seems likely to be finished in this financial year.

John Brannan has sent a letter to Shane Rattenbury, the relevant minister, requesting the status of the testing process, and for intrinsic support of the project from Government. We are awaiting his response.

## 19) Information, outreach and website

### a) Newsletter, flyers, brochure

i) The newsletter is in abeyance for the time being, until further notice.

ii) Brochures are in train and will be completed as soon as possible. They will include maps and tracks and how to find the Pinnacle. Sue's previous words will be used as a basis.

iii) Heather asked for photos to use on the noticeboard. She wished to represent the wider community and their involvement in our display.

Elizabeth will provide further planning information to CC for their consideration and/or agreement.

Proposed banners and brochures for fotpin, if available in time, would be very useful for the walks and continuing PR.

### f) Website update/priorities

There have been no major changes since the last meeting, but incremental updates. The number of unique visitors in the three months December 2012 to January 2013 was 452 (compared with 656 for the previous 3 months and 383 for the same months in 2011-12). "Recent Weeding" continues to be the most accessed page on our site.

*g) Other*

It has been proposed that we explore a 'flag' for fotpin activities, in the form of a 'teardrop' banner, sandwich board and/or similar promotional item to identify fotpin when we hold walks, sausage sizzles, kangaroo counts and so forth at the Pinnacle. Discussed at the previous meeting (Item 20 f ii). John and Elizabeth were to follow-up implementation and possible funding from Ginninderra Catchment Group.

## **fotpin Convenor's Report**

*December 2012 to February 2013*

In the last 3 months, fotpin has made some good progress on a number of fronts.

Due to the very hot and dry weather (officially Australia's hottest ever Summer, I heard today), the weed infestation burden eased slightly and so our weeding effort numbers are slightly down on last year. But that meant that we were able to target more effort into the Bottom Pinnacle and North Kama, which is a very worthwhile investment in the future. I was told by the senior ranger for this part of the ACT that our efforts have not gone unnoticed by the higher echelons of PCS, and they are very appreciative of the effort we've put in, particularly in terms of tackling St Johns Wort. Of all the fotpin activities, our weeding program may be the most demanding, but it is also certainly the most important and the most rewarding in terms of the outcomes achieved. Everyone involved deserves the highest praise for their hard work.

We are now looking at two planting events in the coming Autumn, and following in-principle approval by PCS, we're now able to start working out the details. Some clear announcements should be possible in the next couple of weeks. One planting, to be held at the bottom end of North Kama, will continue the work of the ACT Government and Greening Australia towards the Woodland Restoration Project. The other will be primarily and understory planting, most likely along the northern edge of Kama paddock. It will be aimed at further extending the high-conservation value areas of the Forest block into adjacent woodlands and grasslands.

I attended a very productive meeting with the PCS rangers (which I have already reported on at length elsewhere), and I am optimistic that this will mark the beginning of an improved and more constructive relationship between fotpin and PCS (or PACS, if you prefer). It was decided that such meetings are now to be regular events, since they provide a far more efficient and less error-prone method of communication than the email exchanges that have been the past practice much of the time. The idea is that we meet with PCS shortly after each committee meeting.

After a long period of inaction, there may at last be some real progress on the Focal Point project, which was discussed at length at the meeting with PCS. The assessment we've waited so long for should now be happening in the next month or so, and the results of that assessment will determine whether any further progress is possible. If the outcome is positive, we can then begin to formulate concrete plans for how best to use the Focal Point.

One regrettable development was the withdrawal of ISV from its proposed collaboration with fotpin. Lack of funds has forced them to cut back their programs and it seems that there is little chance at this point of a resumption any time soon.

In addition to the two planting events, this Autumn also sees The Pinnacle as a focus for a couple of Canberra Heritage Festival events. This presents us with an opportunity to bring the reserve to the attention of a wider audience, and the two walks planned for late April will, weather permitting, present some of the lovelier facets of The Pinnacle. It would be ideal if we could have our new brochure ready to go by then, and I am working to bring that about. There will also be another sweep by the PCS rabbit treatment contractors in early April, and another kangaroo count at a date yet to be determined.

**Weed Management Report**

The last 3 months (December to February) have seen 401 hours of weeding effort reported, quite a bit less than in for the same three months the previous season (527 hours). Reasons for this decline include: the weather conditions being much less conducive to weed growth so far this season; the move to more efficient methods (a three-fold increase in spraying this season); and not having an Australia Day weeding event.

The main weed species treated during this period were briars (94 hours), Saffron thistles (77 hours), Verbascum (68 hours) and Thistles (other than saffron – mainly Spear and Scotch - 55 hours).

Other species worth mentioning are St. John's Wort (41 hours), spraying of which ended in December, but bagging of which continues, and African Lovegrass (24 hours), the nastiest weed we have in relative abundance (though thanks to the efforts of our members in far less abundance than in many other places).

The species mentioned above accounted for 90% of the effort in this 3 month period.

Just over a third of our effort in the last three months has been spent in the neighbouring Bottom Pinnacle and North Kama paddocks. This is nearly 3 times the amount of effort spent off-Reserve in the corresponding three months last season. A large percentage of which was a concerted effort to slash Saffron thistles which, unlike on the Reserve where our efforts in the 2010-11 seem to have been effective in keeping the numbers down, have not previously been slashed. Considerable time was also spent lopping and bagging Verbascum.

The late January rain and the follow-up at the end of February has seen the germination of a lot of new weeds, notably Paterson's curse and Verbascum, but likely thistles as well. These should keep us busy during the next three months.
