# Coordinating Committee Meeting Monday 6<sup>th</sup> February 2023 7-30 pm Minutes

#### 1. Apologies

#### 2. Minutes of the Last Meeting / Business Arising

It was moved by John and seconded by Warren that the Minutes of the Coordinating Committee meeting held on 7<sup>th</sup> November 2022 be accepted as a true and fair record of that meeting. Agreed.

#### a. Consideration of Actions carried forward from previous meetings:

#### 20221107: Item 5 Treasurer's report

**Action:** John to contact Kat McGilp regarding reporting of grant money held by GCG for fotpin.

Completed. This was discussed further under Item 5 Treasurer's Report.

#### 20221107: Item 11 Other Business

**Action:** John to contact Wally Bell (Ngunnawal elder) and Kat McGilp (GCG) re First Nation's language content on signs.

In progress. John has contacted Wally, and will follow-up with him.

#### 20220908: Item 12 Business Arising

**Action:** John to request PCS to update fotpin brochure on the PCS website.

**Pending.** Warren will find the link in question and forward to John to query PCS.

**Action:** John will ask Lauren to remedy the missing entries on the ParkCare Hub.

**Pending.** John has asked Lauren but has yet to check if this has been addressed.

#### 20220207: Item 2 Business Arising

Action: John to work with Len to produce laminated signs for the seed sites.

Completed.

#### 3. Correspondence in and out (Attachment A)

Noted.

**Business arising** (other than that to be dealt with under other items):

None.

#### 4. Convenor's Report (Attachment B)

John had previously circulated his report. The main topics included:

- Overview of general conditions on the reserve, including weed control. Warren queried John's statement that weeds other than St John's Wort were under control, John agreed to amend this.
- The Interpretive signage project. This was also covered further under Item 11 Interpretive Signage. Mike queried the implications of the Harden-Murrumburrah Landcare Group (HMLG) donation that is being used for project, including any requirement to acknowledge the funding in the signage.
- The Molongolo Watermain Revegetation project. John reported that trial seedings in the Icon water tanks compound have been disappointing. John suggested that it may be more effective to copy Kelzang's strategy of soil improvement followed by planting trees and shrubs. Mike queried how firm the August 2023 deadline for spending the watermain corridor revegetation grant is. John noted that he has attempted to get clarification of this and request an extension of 1-2 years, but to date has received no reply.
- The successful November bird walk and Weetangera Primary School fete.

**Action:** Mike to email Julian in the GCG for advice on how firm the deadline for spending the watermain corridor revegetation grant money is.

**Action:** John to meet with John Fitz Gerald to develop a plan for next steps in the watermain revegetation project.

#### 5. Treasurer's Report (Attachment C)

Mike had previously circulated the report for the period 1 November 2022 to 31 Jan 2023. Mike reported that the clarification of the process for spending grant monies is still being developed He will formulate a proposed process and email it to GCG for comment, then forward it to fotpin CC members for approval. Warren requested that he be paid the money he is owed. Mike will action this.

**Action:** Mike to clarify process for spending grant monies with GCG, then circulate the agreed process to the fotpin CC for approval.

#### 6. Membership Report

Warren had previously circulated his report. He noted that the current membership remains unchanged at 108. The number of other people who have requested to be on our email lists increased by 2 to 228, making the total number of people on the email lists 336.

#### 7. Weed Management

Weeding effort in the 3 months since the last meeting (November to January) was 316 hours, 36% more than for the same 3 months last season but 11% below average for those three months for the previous 12 seasons. The largest proportion of effort (39%) was spent spraying St. John's Wort. Top non-spraying targets were Miscellaneous broadleaf weeds and grasses (28%, primarily in Weetangera paddock) and Spear and other thistles (17%). The next largest effort was spraying of Briars and Blackberries (7%)

Ranger Kelzang was able to obtain funds from the Offsets budget for a contractor to spray St. John's Wort in much of the less sensitive areas of Kama Link paddock as well as nearby areas in

the main reserve as a buffer. Efforts in the rest of the reserve have concentrated on areas with the most native plant diversity and Eastern and Weetangera paddocks.

There has been an outbreak of Blackberries this season, with more than there has been for 10 years. Warren requested that anyone spotting blackberries on the reserve report their location.

The briar prevalence to this point of the season seems no greater than in the past couple of seasons, which was about 5% of the number 10 years ago. Overall, Verbascum is present in reduced numbers this season as well, especially V. thapsus. The analysis of the Verbascum monitoring patch at 5-ways has been updated to include the 2022 data and continues to show that summer rainfall is one key determinant of Verbascum prevalence in the following year, but that continued control can reduce the actual prevalence below that predicted from rainfall.

A summary of weed control <u>effort for the first six months of the 2022-2023 season</u> is available on the website.

#### 8. Information and Outreach

#### a. Website

No significant additions were made to the website in the last 3 months apart from updating the Verbascum analysis at 5-ways and routine monthly updates.

Another regularly updated page is the Flora and Fauna page and its linked native species count and plant lists. Since the numbers were tallied for the August Update we have added 28 new native species in the Reserve which brings the total to 898. This included 12 new native plant species, bringing the total number of those to 259.

Two of the shrub species added to our list in in the past 18 months have now been found to be widely distributed across the reserve (though not in large numbers), namely *Olearia lirata* (Snowy daisybush) and *Cassinia aculeata subsp. aculeata* (Common cassinia, Dolly bush).

The number of unique visitors in the 3 months since November 1st has averaged 203/month which is right on the long-term average for the last few years but 9% down on the previous 3 months (Aug-Oct).

Interest in walking pages has almost dropped back to the pre-Covid level.

"Recent weeding" (145 unique views) was the most sought after page in this period, followed by "Newsletters" (86 unique views), the walking track map page (59 unique views), The Verbascum story at 5 ways page (42 unique views), Weeds home page (40 unique views), "About the Pinnacle" (33 unique views), "Plants of The Pinnacle" (31 unique views), the Erosion page (27 unique views) and the "Walking home page" (25 unique views).

#### b. Social Media

Denise reported that there were 457 followers on the facebook page, up by 4, and 131 followers on Instagram, which is up by 3.

#### 9. Events Program

Upcoming events include:

- A bird walk in May
- The Hawker Primary School fete, although this has yet to be confirmed

There was some discussion on other possible events, including different types of walk. Denise suggested that Warren lead a walk on the best parts of the Reserve, including those with the most biodiversity. Denise also suggested revisiting the walk previously lead by ranger Craig. Warren will consider developing a walk based on the European history in the Reserve, which would fill a gap in autumn when wildflower walks are less interesting.

**Action:** John to contact Hawker Primary School to confirm if/when their fete will be.

**Action:** Warren to consider developing new walks based on biodiversity and European history in the Reserve.

#### 10. Weetangera Groundcover Revegetation Project Report (Attachment D)

Len had circulated his report before the meeting. There was some discussion of the problems in direct seeding.

Warren agreed to put Weetangera Ground Cover Plantings in Attachment D on the Revegetation section of Fotpin web and also to make Len's map more like the others on that section.

#### 11. Interpretive signage

John reported on the establishment of a working group for this project, and progress to date. See Item 4 Convenor's report for more details. Denise questioned whether directional signage on the Kama Link trail could be included, as the path was very unclear. John advised that there was not enough money for this. Anne mentioned that Alana has written clear walking track instructions for this, which should help.

**Action:** John to develop a timeline for this project.

#### 12. Other Business

- a. <u>Proposed new Territory Plan:</u> Prior to the meeting Len had raised concerns with the plan, which proposes to add a variety of allowable uses, including hydrogen production, to land zoned as "NUZ3 Hills, Ridges and Buffer Zone". This zoning includes some Nature Reserves.
  - While noting that there were various conflicting maps of Land Zones extant on ACT Government websites, Warren circulated the map of land zones for the Belconnen area extracted from the Draft Territory Plan itself. This shows that most of the Pinnacle Nature Reserve is not mapped to zone "NUZ3". The exception is the north-western half of the 2016 Pinnacle Extension (Offset) or Kama Link paddock. Warren expressed surprise that an Offset area might be considered for other than its original purpose, but that we should seek clarification from the ACT government. Other nearby reserves such as Kama and Jarramlee (another Offset area) are completely zoned NUZ3. John stated that this is best raised by larger organisations such as Ginninderra Catchment Group.
- b. **Action**: John to raise the proposed new Territory Plan at the next Convenors' meeting and suggest a joint response from GCG. Len queried the correspondence items regarding the development of a weed manual for volunteers. John agreed to forward the relevant emails to him.

#### 13. Proposed date for next meeting.

The next meeting and the AGM will be held on Sunday 21<sup>st</sup> of May, with the CC meeting at 1:30 pm and the AGM at 2:00 pm. There was some discussion of who could be asked as guest speaker at the AGM. Suggestions included someone from the Mulligan's Flat group, who have been doing

interesting things; John or Warren on biodiversity and species mapping in the Reserve; or someone on climate change. John will contact Lauren for suggestions.

**Action:** John to arrange the venue for the AGM.

Meeting closed at 9.00 pm.

### **Convenor's Report**

February 2023

After months of rain and bogged, inaccessible tracks, the reserve has now completely dried out and is fully accessible again. Like last summer, the wet weather has meant that the reserve's wildflowers have put on a wonderful show, particularly the ubiquitous paper daisies. I thought last year was spectacular, but this year has been even better. But, also like last year, the weeds have also benefited from the abundant moisture, with the St John's Wort having a particularly rampant year. We have done our best to keep it under control in the reserve's more pristine areas, but we do not have the resources to manage the Wort over the entire reserve, so some areas have been left to their own devices. The PCS rangers have also been at full stretch, so there has been little help from them this season, though they were able to send contractors in to spray some of the St John's Wort in the Kama Link Paddock. However, we have had considerable success keeping the other weeds under control. (See Warren's Weed Management report.)

#### 1. Interpretive Signage

A few months ago, we set up a working group to address the task of designing and producing interpretive signage for the reserve. The group consists of myself, fotpin Secretary Anne, committee member Alana, and GCG graphic designer Suzanne Richardson. Our tasks include selecting locations and themes for the signs, composing text and selecting images for those themes, and coming up with consistent and attractive designs for the signs. The working group also needs to identify the acknowledgments that need to go on the sign, source any government logos that must be used, and otherwise ensure that the signs meet the requirements of PCS. Thus far, we have selected the locations and tentative themes for five signs. Two will go at the main reserve entrances (Dungowan St in Hawker and Springvale Drive opposite De Salis St in Weetangera), a panorama-style sign will go on the Pinnacle summit, and there will be two trackside signs, one in the Stringybark Forest and the other at the dam. If funds allow, we may also add another trackside sign, which we are thinking of putting on the Pinnacle summit to supplement the panorama sign. We have decided that the main content for the two entrance signs will consist of a welcome to the reserve, including a component in Ngunawal language (to be contributed by Ngunawal elder Wally Bell), a map of the reserve showing recommended walks, and short descriptions of the walks. All the signs will include QR codes linking people to additional information on our website or other relevant websites. Alana and Anne have done some excellent work in choosing, describing and ground-truthing the recommended walks from both entrances, and I have contributed a tentative design for the entrance signs and one of the trackside signs.

On December 22<sup>nd</sup>, the working group met with Claire Conti, Visitor Information Manager for PCS, who will be working with us to ensure that the signs meet the PCS requirements for interpretive signage on CNP reserves.

There is still a great deal to do, but the working group has made great progress towards achieving our goals. In the coming months, Suzanne will pull together the content we have produced into a design that reflects the existing design themes used in fotpin artwork, as well as clearly distinguishing our signage from the PCS signage used on the reserve. Once our designs are complete, we will approach the manufacturer/installer for a quote, at which point we will be able to make a final decision on how many signs we can afford. Our target is to complete the design work in time for sign installation by the end of the current financial year.

#### 2. Molonglo Watermain Revegetation

The results of the trial seeding of the Icon water tanks compound in early September last year have been less than overwhelming, I think it is true to say. I have yet to visit the site for a close inspection with John Fitz Gerald to review the results, but my own inspection suggests to me that perhaps another revegetation strategy might be a better use of the funding we have been given. My current thinking is that we should perhaps take a leaf out of Kelzang's book and use his approach of planting more trees and shrubs in the remainder of the compound, in the hope that this will eventually lead to the accumulation of leaf litter and viable topsoil in which native grasses and forbs can grow. In the next few months, I will consult with John FG on site and try to come to a consensus about how best to proceed.

After having to postpone the walk for a week due to rain (of course!), about a dozen of us enjoyed a very pleasant morning visiting the Weetangera end of the reserve for a change. In starting the walk from the De Salis St car park, my hope was to be able to spend more time in the woodlands around the dam, which have been a very fruitful breeding site for some of our visiting migrants in the last few years. I'm pleased to say that, out of a relatively low total of 22 species for the morning, we were able to view 5 different species in various breeding activities, including Noisy Friarbirds, Weebills, Willie Wagtails and Leaden Flycatchers all building nests, and Magpie Larks feeding young chicks in their nest.

#### Weetangera Primary School Fete – December 4

After having to cancel their annual fete for the last few years due to COVID, Weetangera Primary were finally able to hold the event this year, and it was a great success. The fotpin stall was kept busy throughout with a number of people signing up to join the fotpin contact list. Many thanks to everyone who helped out, particularly Mike and Denise who stepped in to do the setup.

#### Attachment D Weetangera Paddock Ground Cover Revegetation Update

#### **Direct Seeding**

Since the November 2020 report it was noticed that sorrel seeds disturbed by raking germinated .many more seedlings than the microlaena the microlaena did. Since it was possible to kill these with Agritone (MCPA) spray and we knew that it would not kill mature microlaena we had no other real choice but to spray and hope that the microlaena seedlings were not badly effected. Whilst this was successful the couple of weeks of dry weather later appeared to take a toll on some of the microlaena seedlings (now about 10mm high). There will be more work to do before we get good coverage.

#### **Planting**

Only 13 Dichopogon fimbriatus tube stock have been planted and these were probably not ready to plant out (reasons given last November 2022 report) but no real choice because they naturally die back in summer.

However Jack Holland kindly donated a number of potted Rytidosperma richardsonii and Themeda triandra to John Brannan. Of these John, Grahame and Tom planted out 16 Rytidosperma richardsonii and some Themeda in Weetangera Paddock.

A summary of our our plantings to date is included in a form (except perhaps the map) which is suitable to go on Revegetation in Other Issues, section of the web.

#### **Weetangera Ground Cover plantings**

Native ground cover of forbs and grasses are an important part of the ecology of the reserve and are sadly lacking. It is very noticeable that kangaroos do not eat the large exotic grasses such as wild oats and phalaris (which is actually toxic to kangaroos) but graze native grasses such as weeping grass (Microlaena stipoides), red leg (Bothriochloa macra) and kangaroo grass (Themeda triandra). Not so easy to notice is that forbs attract butterflies and moths as well as providing habitat and food for small birds. Adult eastern bearded dragons are vegetarian and would feed on this native ground cover.

These native plants have another important benefit in that they survive controlled burns and also provide a lower fire fuel load than the taller exotic grasses such as wild oats and phalaris. Experiments in Victoria have shown that that native grass pasture burns with three times less intensity than introduced grasses.


The Saturday morning volunteers have been growing grasses and forbs from seeds and planting this tube stock in the Weetangera Paddock. This has been supplemented by a purchase of 20 tube stock purchased from Greening Australia with Fotpin funds and some plants kindly donated by John Fitzgerald and Jack Holland. All of these are listed below in chronological order. Besides the Saturday morning volunteers the following help was given.

- Seeds were donated mainly by John Fitzgerald with some from Ken Hodgkinson and Rosemary Blemings. Len Taylor also collected seeds from the Pinnacle.
- In 2021 students and teachers, Melanie Monaghan and Katherine Talbot, from St Frances Xavier College kindly grew on about 120 of the tube stock raised from seed were grown. Also Timothy Gill's daughter, Yolanda, helped him plant out the Anthosachne scabra.
- Jean Taylor was heavily committed to watering seedlings to ensure their survival until established and regularly came to the aid when planting out was not progressing well.

At a rough guess the survival rate to date has been close to 90%. However the real test of benefit to the reserve is if they manage to multiply. So far we have only monitored success in this regard with Microlaena, Austrostipa bigeniculata, Leucochrysum albicans and Xerochrysum viscosum.

Weeding is a vitally important part of the work that all Fotpin volunteers do. It is also the main work of the Saturday volunteers and is also necessary to weed for successful planting and establishment of ground cover.
