1. Apologies

2. [Minutes of the Last Meeting](#) / Business Arising

Mike noted that there was a minor typographical error in the previous Treasurer's Report. The meeting agreed to accept this and include it in the Minutes of the previous meeting.

It was moved by John and seconded by Warren that the updated Minutes of the Coordinating Committee meeting held on 16th August 2023 be accepted as a true and fair record of that meeting. Agreed.

3. Correspondence in and out ([Attachment A](#))

Noted. Warren requested more information on the Invasive Plants Working Group. John will investigate.

Business arising (other than that to be dealt with under other items):

None.

Action Item: John to forward information about the Invasive Plants Working Group to Warren.

4. Convenor's Report

John circulated his report before the meeting. The main topics included:

- Spring walks: these have been a success. John requested Warren to add more detail to the description of the wildflower walk.
- Interpretive signage: This is discussed further under Item 5 below.
- Molonglo Pipeline Revegetation Plot: The fences for the seeding trial plots have been raised.
- Upcoming events: The second bird walk of the season will be held on Sunday 13th November.

- Annual Planning meeting: Main outcomes include news that some track maintenance will be carried out in the Reserve, and there may be some contracted out weed spraying.
- Jo Clay's Private Members Motion to the ACT Legislative Assembly.

Action Item: John to follow up on the outcome of the Offset Strategy Review.

5. Interpretive Signage

The signs have been submitted to PCS for approval, and Screenmakers have forwarded to us some draft designs. One of the Entrance Sign designs has been sent to Wally Bell for verification of the First Nation's content.

There was some discussion of a launch for the signs once they have been installed. The meeting agreed that this was a good idea, and discussed inviting Jo Clay and representatives of the Harden-Murrumburrah Land Care Group, as well as others who have contributed money or content to the signs. It was agreed that the launch should be held early in the new year.

Action Item: John to circulate draft designs of the signs from Screenmakers.

Action Item: John to set up a meeting with Screenmakers re draft designs and plans for installation of signs.

Action Item: Warren to complete the QR codes for the signs.

6. Treasurer's Report ([Attachment B](#))

Mike had previously circulated the report for the period 1 August to 31 October 2023. There was one donation during this period. Warren queried footnotes (d) and (e) of Note 2. Mike replied that this and other issues will hopefully be clarified when he met with Kat from the GCG.

Warren moved and John seconded that the Treasurer's Report be accepted. Agreed.

Action Item: Mike to seek written confirmation that the funding for the Molonglo Watermain Corridor vegetation has been extended beyond 15 August 2023.

7. Membership Report

Warren had previously circulated his report. Membership remains at 110, and the total number on the email list has increased to 348, an all-time high.

8. Weed Management

Warren had previously circulated his report on the weeding effort for the three months to 31st October. The total was 175 hours (51% of which was in the Weetangera paddock). The largest proportion of effort (58%) was spent on Miscellaneous broadleaf weeds (82% in the Weetangera paddock) followed by Paterson's Curse (22%).

The summary of [effort for the 2023-24 season](#) to date (July to October) is available on the website.

Overall the season is proceeding as predicted with lower densities of the major weed targets than the previous 3 seasons thanks to the very low rainfall and strong growth of trees and shrubs (as a result of the previous good seasons) drying the soil through winter.

9. Information and Outreach

(a) Website. No major changes in the last 3 months to the current website apart from routine updates, but a new history section is being created for incorporation once the new website is rolled out. The number of unique visitors in the 3 months since August 1st has averaged 213/month, slightly above the long-term average for the last few years, the previous 3 months (May-July) and the August-October period last year. "Recent weeding" (181 views) was the most sought after page on our site in this period.

(b) Social media. Denise reported that there were 517 followers on the facebook/meta page, up by 27 from last report. There were 151 followers on Instagram, up by 10.

10. Events program

There is one remaining bird walk in the Spring calendar.

There was some discussion on events for the Autumn calendar. Suggestions include:

- A Wellbeing Walk such as that previously hosted by Sally Holliday.
- Investigating a technology package for wellbeing, that involves posting QR codes at selected sites in the Reserve.
- Another European History walk. Warren thought that there would not be the demand to repeat these too often.
- Mike suggested an 'explore Kama' walk taking in Kama Link paddock as well as the former Kama Reserve (now part of Molonglo River Reserve).

Action Item: John to follow up with Sally Holliday re a Wellbeing Walk.

11. Weetangera Groundcover Revegetation Project Report ([Attachment C](#))

Len had previously circulated his report. He noted that due to the low rainfall some *Microleana* seedlings have the appearance of dying. However this occurs naturally with mature stands as they become dormant so it is not known if the seedlings are dead or merely dormant. He will grow less seedlings due to the higher watering requirements.

12. Molonglo Pipeline revegetation project

This was covered in Item 4. Convenor's Report above.

13. Other Business

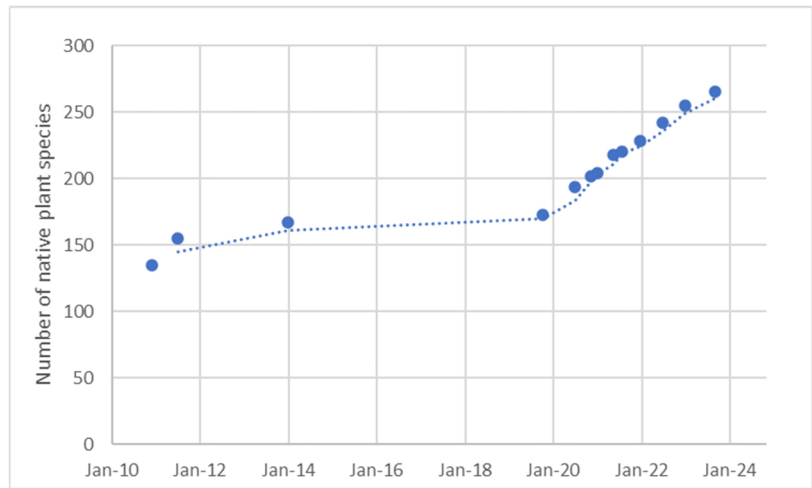
(a) Biodiversity report

Warren reported that Canberra Nature Map has initiated a "[Species Richness Score](#)" (SRS) for each of the areas it consolidates observations for. Pleasingly the Pinnacle Nature Reserve ranks 5th of the Canberra Nature Reserves, behind Aranda Bushland, Mt. Ainslie, Black Mountain and Mt. Painter. (Normalised for total area we rank 3rd).

Current total native species numbers: Total: 922; Plants: 266

Other news: the *Thelymitra* sun orchid, previously only found in the Macrorhyncha Forest, was found last month in both Kama Link and the Dam paddocks where the two patches of woodland are that have the next most diverse native flora after the Macrorhyncha forest. In addition *Diuris sulphurea* (tiger orchids) were found in Kama Link for the first time. These findings are a significant boost to the natural value of those areas.

The graph shows how our known number of native plant species has changed over time from when Warren inherited the list from Rosemary Blemings. The effect of the favourable conditions and increased interest through Canberra Nature Map in the last 3 years are clearly shown.

Attachment C Weetangera Paddock Ground Cover Revegetation Report

Fencing

The small thin wire fence around the Wallaby Grass has been dismantled except for the star pickets. This will be erected around recently planted *Dichopogon frimbriatus*.

Direct Seeding

Fenced Site 3.

The broad leafed weed growth has been controlled by spraying with Agritone. However there is a lot of *Vulpia* and Yorkshire fog out numbering the *Microleana*

In areas elsewhere in the reserve quite a number of long established areas of self sown *Microleana* have browned off with the appearance of being dead. This has also occurred within our fenced area as the *Microleana* seedlings are still quite small and we have no idea whether their roots and rhizomes will be developed enough to withstand a hot dry summer.

Tube Stock Germination.

Just over 100 tubes of *Themeda triandra* have been very recently sown. Unfortunately due to various matters this was very late.

Tube Stock Planted.

The *Dichopogon frimbriatus* grown from seed has not been very successful. Whilst these initially grew very well they were attacked first by Sulphur crested cockatoos then snails and finally when brought into the sun room small aphids kept attacking them. Although these are small it is hoped that their small tubers will keep alive to the next good growing season. These eight plants have been planted next to a successful single *Dichopogon frimbriatus* which was planted couple of years ago.

Tubes and Frames

All tubes and frames borrowed from Sarah Hnatiuk have been returned.

Future Work

Seeds and tube stock of grasses and forbs need damp soil to get them established so in dry conditions they need regular watering. With El Nino likely to last a few years coupled with the effects of climate change it is sensible to reduce our ground cover re-vegetation work.
