Minutes

Present on-line: John Brannan (Convenor), Warren Bond, Len Taylor (phone only), Anne Aisbett, Alana Wilkes (until Item 5).

1. Apologies

Mike Hall, Denise Hall.

2. [Minutes of the Last Meeting](#) / Business Arising

It was moved by John and seconded by Warren that the Minutes of the Coordinating Committee meeting held on 21st May 2023 be accepted as a true and fair record of that meeting. Agreed.

a. Consideration of Actions carried forward from previous meetings:

20230206: Item 4 Convenor's Report

Action: Mike to email Julian in the GCG for advice on how firm the deadline for spending the watermain corridor revegetation grant money is.

Completed. John has contacted Kat at the GCG who advised that the grant money is still available, and will presumably be so indefinitely.

Action: John to meet with John Fitz Gerald to develop a plan for next steps in the watermain revegetation project.

Completed. A plan and fencing for the site will be developed.

20230206: Item 5 Treasurer's Report

Action: Mike to clarify process for spending grant monies with GCG, then circulate the agreed process to the fotpin CC for approval.

20230206: Item 9 Events Program

Action: John to contact Weetangera Primary School to confirm if/when their fete will be.

In progress: John has emailed the previous fete organisers and received no reply. Alana has not heard anything from the school about the fete, which would normally be the case by now, and believes that the school fete committee may have shifted to a bi-annual event, in which case there would be no fete this year.

20230206: Item 12 Other Business

Action: John to raise the proposed new Territory Plan at the next Convenors' meeting and suggest a joint response from GCG.

Completed. GCG has made a submission to the Territory Plan and to the Gungahlin and Belconnen District Plans.

20220908: Item 12 Business Arising

Action: John to request PCS to update the fotpin brochure on the PCS website.

In progress: John has requested the update but it has not yet been actioned, and the ParkCare Hub also needs updating.

Action: John will ask Lauren to remedy the missing entries on the ParkCare Hub.

3. Correspondence in and out ([Attachment A](#))

Noted. Some corrections were requested.

Business arising (other than that to be dealt with under other items):

None.

4. Interpretive signage

Drafts of the signs were circulated before the meeting, and some comments and corrections received. This Item was also covered in the Convenor's Report.

There was some discussion of the suggested walking routes on the entrance signs, and John and Alana will review this material. There was also discussion around the approval process, in particular in regard to First Nation's language and text. The inclusion of more historical images in the Panorama sign was also discussed.

Action Item: John to contact Claire Conti in PCS regarding the approvals process(es).

Action Item: John to include instructions regarding the caterpillar game on the Entrance Signs.

Action Item: Alana to continue discussions with Maureen Tully regarding historical images and information.

Action Item: Anne to update the Panorama sign with more historical information, including images from Maureen Tully (if any and available) as well as from Nan Betts, such as her picture of the wool truck, and with a different image of the land blocks.

Action Item: Warren, John and Anne to consider which items to keep in Dropbox and which to delete to meet its space limits.

5. Convenor's Report

John had previously circulated his report. There was some discussion around some of the details, and John will make some amendments as noted below before circulating to the membership. The main topics included:

- Overview of general conditions on the reserve. Warren queried the statement regarding soil moisture and John agreed to amend this
- Upcoming Pinnacle events, covered further in Item 11. below
- The ACT Environmental Volunteers Conference, which John noted was highly successful, including the field visit to The Pinnacle Nature Reserve
- An update on the Molonglo Water Main revegetation, including the disappointing news that Icon are considering constructing a third water tank in the area. Future revegetation efforts will focus on the pipeline corridor further down the hill, and will begin with fencing the area to protect regrowth

- The Interpretive signage project, covered in more detail under Item 4. above
- The PCS Annual Planning Briefing
- A Kama Link paddock planting event held in mid-July, and to be further supplemented with help from the Intrepid Landcare Team from the ANU on 19 August.

Action Item: John to amend the report including details around soil moisture and the historical items to be included in the Interpretive Signage section of the report.

6. Treasurer's Report ([Attachment B](#))

Mike had previously circulated the report for the period 1 May 2023 to 31 July 2023, and was not available to talk to it. Warren moved and John seconded that the Treasurer's Report be accepted. Agreed.

7. Membership Report

Warren had previously circulated his report. Membership has increased by 1 to 110, and the total number on the email list has decreased to 337.

8. Conflict-of-Interest Policy

The Committee Members present at the meeting declared that they had no conflicts of interest. Anne moved and John seconded that the current Conflict-of-Interest Policy be accepted. Agreed.

Action Item: Anne to email absent committee members to request they declare any conflicts of interest.

Action Item: Warren to prepare an Annual Report for The Australian Charities and Not-for-profits Commission.

9. Weed Management

Warren had previously circulated his report on the weeding effort for the three months to 31st July. The total was 217 hours (44% of which was in the Weetangera paddock). This was 16% less than for the same 3 months last season but 46% more than average for those three months for the previous 12 seasons. The largest proportion of effort (43%) was spent on Miscellaneous broadleaf weeds.

John and Warren noted that more sprayers were needed.

10. Information and Outreach

(a) Website. Warren had previously circulated his report. In the last three months, as well as the routine monthly updates to web pages, there have been a number of annual updates: the weeding effort summary for the 2022-23 season, the Briar control page and the Blackberry control page. He noted that more progress has been made on transitioning the website to be more small-screen friendly, with a view to having this completed by the end of the year. The

number of unique visitors in the 3 months since May 1st has averaged 202 per month, close to the long-term average for the last few years.

(b) Social media. Alana reported that there were 490 followers on the facebook page. There was no report on Instagram usage.

11. Events program

Upcoming events include:

- The Joint ParkCare Display at the Jamison Centre
- 2 planned bird walks (in September and November) and a wildflower walk
- Possibly a walk led by Warren to visit features of significance in the history of European settlement and the subsequent establishment of the reserve. Warren and John to consult on a date.
- Possibly a tree walk. John will consider who has expertise to lead this
- Possibly some wellbeing through nature events such as those led by Sally Halliday, or delivered via an app. John will discuss this further with Sally.

12. Weetangera Groundcover Revegetation Project Report

Len had previously circulated his report. He noted that there was very little germination of the seeds sown at any of the sites. In Fenced Site 3, weed germination has been better than the seed generation, but a few native seedlings have started to emerge in the new unfenced site just to the south of Fenced Site 3.

Len reported he is considering discontinuing his efforts in this project, as he has growing health issues and progress is slow.

The meeting noted that an Etrex device was lost during a recent Saturday weeding party.

Action Item: The committee will ask Mike to develop an Assets Register.

13. Molonglo Pipeline revegetation project

This was covered in Item 5. Convenor's Report above.

14. Other Business

None.

15. Proposed date for next meeting.

The next meeting is proposed for Monday 6th November, in person if possible. John agreed to host.
